## **Guidelines**

## **Building**

- -Classrooms will be set up to support physical distancing with the use of alternate space as needed. This will include the Bridge (Aberdeen) and the Deaf Chapel (Hargrave). Two metres of physical distancing is required to the greatest extent possible.
- -Entering and exiting the school will be managed to avoid congestion.
- -Lunch and recess breaks will be staggered.
- -Rules will be in place to safely move students through the school to reduce crowding in the hallways and common areas.
- -There will be extra cleaning in the classrooms and the washrooms.

## **Parent/Student Responsibilities**

- -Students are expected to attend school every day. If they are not able to attend, they are expected to complete 100% of the required assignments.
- -Parents/Guardians are expected to keep their children home if they are not healthy. If a child becomes sick at school, they will be isolated and given a mask. The parent/guardian will be contacted and MUST pick up their child as soon as possible.
- -If Parents/Guardians are at work, they need to be prepared and have a person available to pick up their child.
- -Students will be expected to sanitize and wash hands regularly.
- -Students need to bring their own snack and lunches and they are not allowed to share their food.
- -Students should bring their own water bottles which can be filled at school.
- -Students will have their own school supplies which will be labelled and these should not be shared.

## **Staff Responsibilities and Learning**

- -Teachers will do regular assessments of the students to make sure they are receiving recovery learning or are working at grade level or beyond.
- -Teachers and Administration will communicate frequently through email, phone calls and letters.
- -The classroom, desks, equipment, etc will be cleaned and sanitized throughout the day.
- -Physical Education and Music classes will resume, however, the mandatory guidelines from the Provincial Government will be followed. Ex no choir, separate equipment where possible
- -The Mental health and well-being of the students and staff will be monitored closely, and help will be provided where possible.
- -At the Aberdeen campus, the cafeteria will follow the guidelines mandated by the Government.
- -Students travelling to the Shops Program at Niji Makhwa on the bus, will be required to sit in separate seats. Provincial Transportation Guidelines will be followed.
